Privacy Notice For Employees

Isuzu Motors Asia (Thailand) Company Limited and its affiliates (as listed in the annex) (collectively referred to as "we") are committed to protect personal data of employees (hereinafter referred to as "you") pursuant to Personal Data Protection Act B.E. 2562 ("PDPA")

In this privacy notice, we are a data controller who collects, uses, or discloses your personal data under PDPA.

To comply with PDPA, a data controller must inform a data subject of the purpose of the collection of personal data based on the lawful basis; retention period; the categories of persons or entities to whom the collected personal data may be disclosed; and rights of data subject, we, therefore, publish this privacy notice for employees under section 23 of PDPA.

This privacy notice under section 23 of PDPA is announced by Isuzu Motors Asia (Thailand) Company Limited and the companies as listed in the annex. Unless a company has its own specific privacy notice and publishes its privacy notice under this section 23 of PDPA, this privacy notice shall not apply to such company.

We may update this privacy notice from time to time as appropriate. In the event this privacy notice is amended, we will announce an updated privacy notice on this website. This privacy notice will be effective immediately on the date of announcement.

1. What Personal Data We Collect

Personal Data means any information relating to a natural person, which enables the identification of such natural person, whether directly or indirectly, but not including the information of the deceased persons in particular. We may collect many types of personal data depending on the purpose of processing such data which include personal data as follows.

1.1 Identity information and personal information relating to employees, for example, first name, last name, date of birth, age, gender, marital status, interests, opinions, education, ability including other qualifications, working experience, information about past employment, picture, motion picture, audio, information about military obligations, information about habits, behaviors, attitudes, aptitude, skills, documents that can be used to identity you or issued by the government agencies, your vehicles, driving license;

- 1.2 Employee contact information, for example, address, telephone number, email, social media information, information about your emergency contact person, reference person
- 1.3 Financial data or information regarding payment to employees, for example, information about wage, salary, income, tax, provident fund, bank account, loans, tax deductions or exemptions
- 1.4 Information about working, for example, information about workable locations, time attendance records, duration of work, overtime, absence, and leave, working experience, position, meeting attendance, opinions, voting, signing, information in case you are appointed as a director or a shareholder of our company, information necessary for reporting, compliance with laws or regulatory agencies.
- 1.5 Information about human resources management and internal audit, for example, information regarding recruiting process, benefits, welfare, social security and benefits that employees receive or are entitled to receive in accordance with the regulations and personnel management regulations of the company, information about family members or those in the care of employees who are eligible to receive benefits in accordance with the regulations and personnel administration of the company, information about using our IT system including any equipment and information gathering from participation in our activities
- 1.6 Sensitive data for example, health information, biometric information, religious, ethnic religious belief, philosophy, race, nationality, disability, trade union information, information about criminal records
- 1.7 Other information, for example, information necessary for investigating conflicts of interest, information regarding whistleblowing, complaints, and disciplinary investigations, information collected from your participation in our activities as well as your responses in surveys and assessments, information that you choose to share and disclose through our application systems, tools, questionnaires, assessments, various documents, and our services
- 2. Why We Process Your Personal Data
- 2.1 We will collect use and disclose your personal data under following legal basis.
- (1) It is necessary for the performance of a contract to which you is a party or in order to take steps at the request of you prior to entering into a contract, for example, your employment contract including related agreement, any proceeding under employment contract, assigning of works or duties, secondment, training, or any activities, performance appraisal, consideration of positions, staff transfer, compensation, welfares,

providing security measures including compliance with the rules and regulations of our personnel management.

- (2) It is necessary for compliance with a law to which the data controller is subjected e.g. labor law, laws relating to doing business, taxation law, and contagious disease control law.
- (3) It is necessary for legitimate interests of the Data Controller or any other persons or juristic persons other than Data Controller, for example, human resource management, providing welfares, financial and budget management, providing facilities and the proper working environment, management of employees after termination or retirement, internal contact and communication with third parties including government agencies, providing security measures both in physical and IT system, internal audit, handling of complaints and fraud, or disputes.
- (4) It is for preventing or suppressing a danger to a person's life, body or health. for instance, to prevent epidemic, to provide first aid, or to make contact in case of emergency.
- (5) It is necessary for the establishment, compliance, exercise or defense of legal claims
- (6) It is required by law to obtain your explicit consent under PDPA, for example,

- (6.2) Biometric data such as fingerprint and face image data in order to identify and confirm your identity to prevent crime and safeguard legitimate interests of us or other persons

- (6.4) Your sensitive data as shown in identification documents, such as, ID card, passport or other documents issued by government agencies such as religious belief, race, nationality, blood group when it is necessary to use as required by law or to identify and confirm your identity
- (6.5) Your relating personal information for disclosure to customer, business partner, or other persons due to perform rights and duties under employment contract.

- (6.6) Your relating personal information for disclosure to contractor, sub-contractor, service provider or any other agents for providing any works or services to us.
- (6.7) Your relating personal information for disclosure to the person who will become your new employer in case you indicate us as the ex-employer.
 - (6.8) Your relating personal information for disclosure to the affiliates as listed in the annex.
- 2.2 In case, it is necessary for us to collect, use, disclose your personal data in order to perform contract or comply with law, but you do not give such personal data to us. As a result, we may not be able to perform contract or follow your request or violate the laws or having other negative impacts.

3. Changes in the Purpose of Processing Your Personal Data

We will process your personal data within the purpose stated in this privacy notice. If we are necessary to process your personal data for the purposes other sated in this privacy notice, we will immediately notify you.

4. How We Collect Your Personal Data

We will collect your personal data directly from you through our job application website or system. We may also collect your personal data from recruitment services, your ex-employer, or governmental officer which we will notify you of such collection in this privacy notice.

In addition, we will collect your personal data through activities regarding employment during the time you have worked with us.

We will use cookies to collect your personal data when you access to our website. (Please see Cookies Policy of such website you access)

5. Disclosure of Your Personal Data

In case of necessity and achieving the purpose of collecting, use, and disclose your personal data according to this privacy notice, we may disclose your personal data to the following natural persons and juristic person, for example,

- (1) Our affiliates as listed in the annex
- (2) Service providers, contractors, any relating agents, or relating contract parties.
- (3) Government agencies or entities under other laws

6. Transferring Personal Data Overseas

In case of necessity, we may transfer your personal data to our affiliates which are located in foreign countries as listed in the annex

In order to protect your personal data which is transferred to overseas, we have put in place a personal data protection policy regarding the sending or transferring of personal data to another data controller or data processor who is in a foreign country and is in the same affiliated business

7. Security Measures

We have appropriate security measure to protect your personal data from loss, unauthorized access and use, and unauthorized disclose, change, or destruction.

We will have access control only for employees, contractors, representatives, third parties who need to know and perform their duty. If there is any third party processing of your personal data, we will control such third party to process your personal data within our instruction appropriately.

8. Retention Period

We will retain your personal data and information about your family or related persons for the period necessary to meet the objection under this privacy notice. The retention period will depend on the necessity of performance of contracts between us, the necessity of compliance with a legal obligation, or prescriptive period for establishment, compliance, exercise or defense of legal claims.

We will delete or destroy your personal data when the retention period expires or when it becomes irrelevant or unnecessary for the purpose of collecting that personal data.

9. Your Rights as a Data Subject

- 9.1 You have the rights as a Data Subject under PDPA as follows:
 - (1) Withdraw the consent you have given to us;
 - (2) Request to view and copy your personal data or disclose the source where we obtain your personal data;
 - (3) Send or transfer personal data that is in an electronic form as required by personal data protection laws to other data controllers;

(4) Oppose the collection, use, or disclosure of personal information about you;

(5) Delete or destroy or make your personal data non-personally identifiable (anonymous) information;

(6) Suspend the use of your personal data;

(7) Correct your personal information to be current, complete, and not cause misunderstanding; and

(8) Complain to the Personal Data Protection Committee in the event that we, our data processors, our

employees, or our contractors violate or do not comply with personal data protection laws.

9.2 You can exercise the rights under this section 10 by using the Data Subject Request Form, Consent

Withdrawal Form which shows on our website through the contact information in section 10 or you can

contact us directly via such contact information You will be able to exercise your rights when the law is

enforced.
